First Preference:

SMALL PACKAGES

FEDEX – Acct# SEE PURCHASE ORDER FOR ACCOUNT NUMBER INFORMATION (Domestic Inbound/Outbound)

DHL – Acct# SEE PURCHASE ORDER FOR ACCOUNT NUMBER INFORMATION (International Inbound/Outbound)

Second Preference:

UPS – Acct # SEE PURCHASE ORDER FOR ACCOUNT NUMBER INFORMATION (Domestic Inbound/Outbound)

First Preference must be utilized unless Carrier doesn't service the Supplier' area.

Late Shipments

There is zero tolerance for late shipments. A shipment is considered late if it exceeds the ship date indicated on the purchase order. GDRS takes into consideration, late shipments, when we solicit bids and place purchased awards. So please, in your own interest, abide by the Purchase Order schedule.

Packing Slip Issues

There seems to be a greater number of parts coming in from suppliers that are not properly identified or lack the correct paperwork. Please insure that all boxes and containers have the correct packing slips with them. If GDRS requests to have products shipped to a destination other than a GDRS facility, we request a copy of the signed packing slip be forwarded to GDRS's Buyer of record as identified on your Purchase Order.

Purchase Order Number

GDRS receives numerous shipments on a daily basis. In order to identify the package contents quickly and sort appropriately, we are requesting that you include the Purchase Order Number on your packing slip and the shipping label. If the Purchase Order Number is not provided on the shipping documents, it may delay payment of the Invoice.

Thank you for your compliance with this direction. Please refer any questions you may have to the Buyer referenced on your purchase order.

NOTES:

1. "Ship Collect against above referenced account numbers". DO NOT PREPAY AND ADD.
2. Any changes to the shipping arrangements must be made through the Buyer designated on the Purchase Order.
3. GDRS will not accept any COD orders.
4. Third Party Billing – If product is transported between two Third Party locations, neither of which is a bonafide GDRS facility listed above, the following applies: Billing should be "Third Party Collect" to General Dynamics Robotic Systems, 1231 Tech Court, Westminster, MD 21157 – Attn: Accounts Payable.
